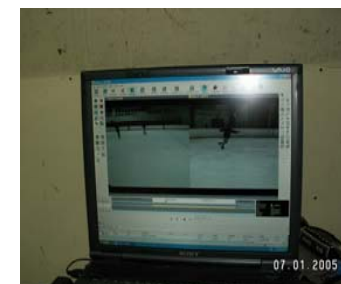
- ⇒ Dartfish software is used at major international sports training facilities, national and Olympic competitions and in national/Olympic television broadcasts.
- ⇒ Performance results can be provided in a CD or DVD format so that the athlete and coach can study their session - and helps to ensure the instructions are understood and practiced properly.
- ⇒ Video sessions are typically done in conjunction with a coach or other trained sports professional
- ⇒ Video and computer analysis is done by a videographer/rated-coach with national-level competitive skating and sports experience and extensive certified computer experience.
- ⇒ There is no need to invest thousands in equipment, buy and learn software, or learn video analysis. The coach can focus on the important elements.
- ⇒ There is no charge for travel within certain distances and depending on the amount of time requested.



The equipment used is highly-sophisticated, yet can be carried by one person across icy or rough environments.
